Terms and Conditions for Aqueduct Marina Moorer's Voucher Package

- 1. **Eligibility**: The voucher package is available exclusively to individuals who sign up for a 12-month mooring at Aqueduct Marina. Voucher books will be issued upon the start of the 12-month mooring period.
- 2. **Voucher Validity**: All vouchers in the package are valid only during the 12-month mooring period. Vouchers are strictly non-transferable unless otherwise specified on the individual voucher.
- 3. **Expiry Date**: Each voucher book will be issued with an expiry date corresponding to the end of the 12-month mooring term. Vouchers cannot be used after this date, nor can they be carried over beyond the initial 12-month period.
- 4. **Redemption Process**: To redeem a voucher, the voucher book must be presented to a member of staff at Aqueduct Marina for stamping. Vouchers will not be considered valid unless stamped and dated by staff at the time of redemption.
